Hong Kong Bar Association and World Justice Project: a conversation on strategies to fight corruption and rule of law in inaugural conference

The Hong Kong Bar Association ("HKBA") and the World Justice Project ("WJP") today (26 August) concluded the inaugural conference, "Absence of Corruption – A Key Requirement for the Rule of Law," bringing together over 100 legal professionals, regulators, and thought leaders to examine anti-corruption strategies critical to maintaining the rule of law across the Asia-Pacific region.

Setting the scene, Mr. Paul Lam SC, Secretary for Justice, delivered the keynote address, noting that Hong Kong in becoming one of the least corrupt places in the world can be attributed to three main factors: first, our comprehensive legal framework; second, strong and independent law enforcement agencies and judiciary; and third, a deep anti-corruption culture in society.

Mr. José Antonio Maurellet SC, Chairman of the HKBA, said, "Rapid technological advancements have prompted corruption across the globe to become increasingly complex and cross-jurisdictional. The legal profession champions the rule of law. By convening leading minds from the judiciary, regulatory bodies, and the legal professions, we reinforce the strategies to ensure integrity remain the core value of our legal system."

This conference marked the inaugural collaboration by the HKBA and the WJP. Mr. Maurellet SC stated that Hong Kong, being an international financial centre, attaches great importance to the rule of law and the independent operation of its judicial system. By hosting conferences with international institutions, the HKBA enables their representatives to visit Hong Kong in person for in-depth face-to-face exchanges with representatives from the local legal community and regulatory bodies. This promotes a better understanding of Hong Kong's role under "One Country, Two Systems" and its characteristics of adopting the common law system.

Dr. Srirak Plipat, Asia Pacific Regional Director of the WJP, made a trip to Hong Kong. In his sharing, he noted that Hong Kong is particularly resilient in the metric "absence of corruption" in the Rule of Law index compiled by the WJP. Mr. Woo Ying Ming, Commissioner of the Independent Commission Against Corruption ("ICAC"), and Dr. Kelvin Wong, Chairman of the Securities and Futures Commission ("SFC"), both graced the event with their thematic speeches.

Nine prominent speakers, including Dr. Srirak Plipat from the WJP, The Hon. Mr. Justice Andrew Colin Macrae, Vice President of the Court of Appeal of the High Court, barristers, a solicitor advocate, a legal scholar, and senior executives of the ICAC and the SFC participated in the two panel discussions, addressing the delivery of effective anti-corruption strategies, the alignment of policies and law enforcement agencies, and the interaction between statutory offences and common law offences.

The half-day conference was held at the Asia Society Hong Kong Centre in the morning of 26 August 2025 (Tuesday). Haldanes served as the exclusive gold sponsor, and the Department of Justice, the ICAC, the SFC and the Law Society of Hong Kong were the supporting organisations of the conference.

The conference was part of HKBA's efforts to strengthen stakeholder communication and external engagements. The HKBA, aiming to further enhance transparency in promoting the rule of law, also launched an official LinkedIn page yesterday.
